

## Vote on May 1

The annual Town Election will be on Tuesday, May 1. Since the boundaries of Precincts 4 and 5 were redrawn this year, we will be voting to fill all 15 Town Meeting Member seats in each precinct rather than the customary 5 slots. Although there are only 15 candidates for the 15 openings in Precinct 5 and 17 for 15 in Precinct 4, your vote will count. In each precinct, the 5 candidates with the highest number of votes will be rewarded with 3-year terms, the next 5 highest with 2-year terms and lowest 5 with one-year terms. All of the HSHA area is in Precinct 5 except for the portion that is both east of High Street and north of Allerton Street which is in Precinct 4. Because of the re-precincting, Precinct 5 has been expanded to extend west to Warren and Cottage Streets.

# Neighborhood Notes

## Greening of Philbrick Square

Heavy use of our local park combined with soil erosion and lack of maintenance have taken its toll. So on March 29, at the request of neighbor Faith Michaels, several residents met with Parks and Open Space Director Erin Gallentine and her management staff to talk about the condition of Philbrick Green (or Square). As a result, the stump of a large old oak has been removed and in the next few weeks a replacement tree will be installed, the lawn will be repaired and reseeded and ruts at the lower end will be filled. In order to give the lawn the time it needs to regenerate, signs will be posted to ask residents to refrain from using the park during this period.

## New Guidelines

Did you know that there are 4 installations of solar photovoltaic panels in Pill Hill and that more are being considered? On April 10 the HSHA Board sent a letter to the Preservation Commission (PC) requesting that the HSHA and the other Local Historic Districts (LHD) be notified of all future drafts of its official guidelines for renewable energy systems and that it allow each organization a reasonable amount of time to comment before these guidelines are discussed or voted on by the PC. We believe that LHD participation will produce the best guidelines, in keeping with our previous discussions with the PC about participation and openness.

## Author! Author! Two More Book Talks

The first of our new *Pill Hill Author Series*, which was held on March 25 and featured Susan Senator, was well attended and very interesting. In the coming weeks you'll have the opportunity to hear from two other distinct voices in the neighborhood:

On Sunday, April 22, **Joseph B. Martin**, former dean of Harvard Medical School and a Hawthorn Road resident, will discuss his book – a combined personal memoir and reflection on education and leadership – *Alfalfa to Ivy: Memoir of a Harvard Medical School Dean*. In the book, Joe traces his roots in a remote Mennonite town in rural Alberta, Canada, to his days at the University of Alberta and medical school, then on to a career at McGill University, Mass. General Hospital, the University of California, San Francisco, and ultimately to a deanship at Harvard, where he and his team located the gene for Huntington's disease. Joe says he wanted to write about "the process of how you get things



done. Academic leadership is hard and erratic and complicated by the big egos that you work with, and some things go well and some things flunk. I wanted this book to be a personal illustration of how those things arose, and were dealt with, and walked away from if they weren't working."

And on Sunday, May 20, **Tina Cassidy** will present her new book, *Jackie After O: One Remarkable Year When Jacqueline Kennedy Onassis Defied Expectations and Rediscovered Her Dreams*. Tina was a reporter and editor at the *Boston Globe* for more than a decade. A relative newcomer to Walnut Street, she also is the author of *Birth: The Surprising History of How We Are Born*, published in 2006.


In her new book, which will be published in May, Tina chronicles a pivotal year in Jackie O's life, when she rediscovered talents and passions she had set aside for her role as public wife. In January 1975, she kicked off a year of great activity and change, including a high-profile role in the campaign to save the landmark status of Grand Central Station in New York City; and the death of her second husband, Aristotle Onassis, the public speculation about his enormous estate, and her tumultuous relationship

with his daughter, Christina. The year also included Jackie's pursuit of her first real career with a job in the editorial department of Viking Press and the early stage of what could have been the most meaningful romantic relationship of her life. These major changes reflect a cultural shift, with women taking on larger roles in the community and in the workplace. *Jackie After O* takes a unique look at this time and at the life of Jacqueline Kennedy Onassis as she shook the world's expectations and pursued her dreams in middle age.
